1. (CDA) operates a transport company servicing remote towns and farming communities.
2. (CDA) has its own clients and deliveries home shopping to them every week, fortnight from COLES.
3. (CDA) loads our clients shopping orders from various COLES online store locations
4. (CDA) customers require the above category items listed above from time to time. These remote customers are traveling long distances to pick up these items or paying very high delivery costs due to a one off drop cost. (which you would already be aware of)
5. (CDA) operates a modern (new and near new) fleet of trucks that have excess room available for these items.
6. (CDA) is seeking a retailer who can receive our customer's online orders.
7. (CDA) customers will be instructed to only place an order of items in a category from our approved retailer in their Zone.
8. Payment Process – Our customers will contact the approved store where they will place their online order and state the delivery will be picked up by Country Deliveries Australia.
9. Our drivers will arrive on your stores dock area and supply proof and customer approval of our pick up for your security. EG: Your company Invoice/Booking/Payment number.
10. Once any item is loaded at your dock (CDA) take full responsibility for that item under our cartage insurance. Should any issue or unfortunate accident happen on our delivery then (CDA) insurance is fully responsible for the replacement and delivery again of that those same item/s. Once our delivery is completed successfully and then unpacked by the consumer who has any issues would fall under the manufactures warranty or they would contact your store.
11. Should a (CDA) customer find any item priced lower then our exclusive retailer (from one of your competitors) for that same item then CDA will reduce the delivery cost so our approved retailer can secure the sale?

## AGREEMENT

1. The exclusive delivery location (Zone) for this agreement in Western Australia is for our location as selected in the **schedule**. In Perth WA we have three (ZONE) locations. 1 North, 2 East, 3 South. 3 even slices from Perth city to north, east and south,
2. Each (Zone) for one category is a payment of \$10,000 plus GST.
3. This payment can only be renewed when CDA have supplied X \$dollars to the retailer and this amount is set by the retailer.
4. The retailer agrees to renew and pay \$10,000 again once they have received  
\$ \_\_\_\_\_ in sales from CDA customers within 12 months.

5. In the event CDA do not achieve this \$ figure within 12 months then CDA will refund the \$10,000 plus 20% interest and continue to work with that retailer.
